CROWN SYDNEY LIQUOR LICENCE – UPDATE

MELBOURNE: Crown Resorts Limited (ASX: CWN) (Crown) refers to its announcement of 16 December 2020 and announced today that the New South Wales Independent Liquor and Gaming Authority (ILGA) has granted new liquor licences to Crown Sydney Property Pty Ltd which will allow for the continued service of alcohol in non-gaming areas of Crown Sydney beyond the expiry of the current liquor licences.

The new liquor licences have been granted for the period 1 May 2021 to 31 October 2021.

Crown's Executive Chairman, Helen Coonan, said:

“Crown is continuing to work through the consultation process with ILGA as it seeks to restore regulatory confidence in its operations and give effect to the Restricted Gaming Licence in Sydney.

“Crown welcomes ILGA's approval of the new liquor licences for Crown Sydney Property Pty Ltd which will allow guests to continue to enjoy the non-gaming facilities at Crown Sydney as we work through this process.”

LIQUOR LICENCES APPROVED FOR CROWN'S BARANGAROO CASINO

The NSW Independent Liquor & Gaming Authority has today approved three interim liquor licences for Crown's Barangaroo resort.

The licences permit alcohol to continue to be sold within the Crown Barangaroo resort at a number of non-gaming bar areas and two ground floor restaurants within the facility.

ILGA chair Philip Crawford said the licences had again been issued on an interim basis and will expire on 31 October 2021. Three interim licences were issued last December prior to the opening of non-gaming areas.

"Late last year, ILGA agreed to work with Crown Resorts to enable the opening of accommodation, restaurants, bars and entertainment areas," Mr Crawford said.

However, ILGA's position on Crown Sydney's gaming operations has not changed with the Authority still considering and assessing Crown's responses to the issues arising from the Bergin Report.

"These issues are detailed and complex, and Crown is required to undertake significant change to satisfy the Authority that it is on a pathway to regain suitability to hold a gaming licence. It will take time for Crown to fully implement that change and for the Authority to give it proper consideration before determining the most appropriate course of action," Mr Crawford said.
