- Download the Lumi AGM app from the Apple App Store or the Google Play Store.

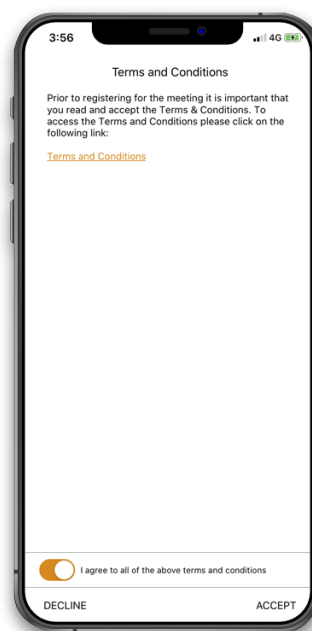
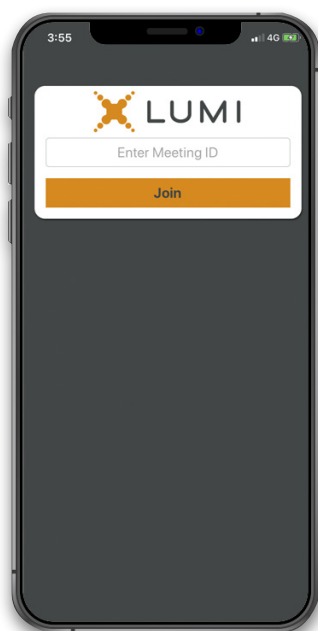

3 To register as a Shareholder, select ‘Securityholder or Proxy’ and enter your SRN or HIN and Postcode (Australian residents) or your SRN or HIN and your country code (overseas residents)



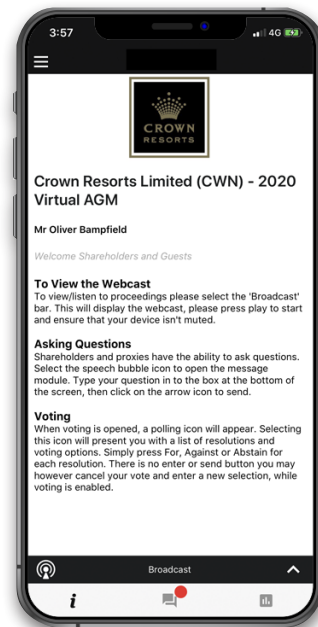
4 To register as a Proxy, select ‘Securityholder or Proxy’ and enter your username and password as provided by Computershare. In the ‘SRN or HIN’ field, enter your username, and in the ‘Postcode or Country Code’ field enter your password.



5 To register as a Guest, select ‘Guest’ and enter your name and email address.



6 Once logged in, you will see the home page, which displays the meeting title and name of the registered shareholder or nominated proxy.

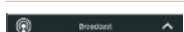

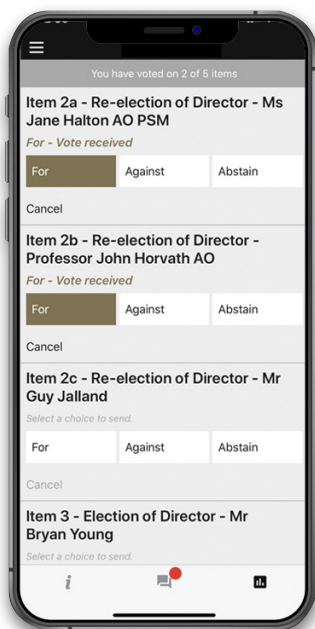
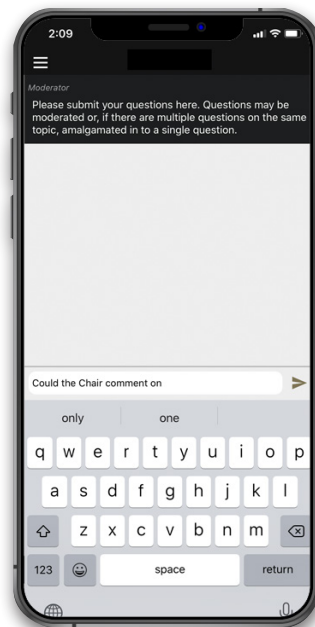

7 To view the live webcast, tap the broadcast arrow on your screen and press the play button. Toggle between the up and down arrow to switch between screens.



8 To ask a question during the Meeting, tap on the question icon, type your question in the chat box at the bottom of the screen and select the send icon. You will receive a confirmation when your question has been submitted.



9 When the Chairman declares the poll open:

- > A voting icon  will appear on screen and the Meeting resolutions will be displayed.
- > To vote, tap one of the voting options. Your response will be highlighted.
- > To change your vote, simply press a different option to override.

The number of items you have voted on or are yet to vote, will be displayed at the top of the screen. Votes may be changed up to the time the Chairman declares the poll closed.
